## **BUILDING**

Palm Court at Hidden River is a one story suburban office building built in 1989 consisting of approximately 60,000 square feet.

## **LOCATION**

Palm Court is located in Hidden River Corporate Park at the intersection of Interstate I-75 and Fletcher Avenue and offers easy access to the executive housing areas of "New Tampa", Brandon and Temple Terrace. It is also near the University of South Florida, hotels, restaurants, Lettuce Lake Park, Busch Gardens, the Museum of Science and Industry, and is close to some of Tampa's finest golf courses, including Tampa Palms, Hunter's Green and Saddlebrook.

## **AMENITIES**

Hidden River is a Verizon Smart Park with Fios availability. Each suite offers exterior signage and individual direct outdoor entry.

## **PARKING**

Palm Court offers 4.5 parking spaces per 1,000 RSF at no charge.

## **BUILDING HOURS**

Tenants have 24/7 access to their premises and the suite is individually metered for full tenant heating, ventilation and air conditioning controls.

## **BUILDING SECURITY**

The Hidden River Corporate Park offers patrolled security during the evening hours.

Palm Court is owned, managed and leased by Osprey. The property management staff is available to respond to service requests, maintenance of the building and its mechanical systems.
